

## Consent For Electronic Disclosures

- **Introduction.** In order for you to participate in the BeVerified website as either a borrower, or lender, from time to time you will receive notices, disclosures, information and documents, and e-mails ("Communications") from BeVerified, Inc. ("we" or "us"). Your consent applies to all documents and communications we provide, including your use of the site. We can only give you the benefits of our service by conducting business through the Internet, and therefore we need you to consent to our giving you Communications electronically. This statement informs you of your rights when receiving Communications from us electronically.
- **Consenting To Do Business Electronically.** When you register with us, you agree that all Communications from us relating to your use of the BeVerified website may be provided or made available to you electronically by e-mail. If you consent, you still have the right to receive a free paper copy of any Communication by contacting us in the manner described below. Please be advised the site may be unavailable from time to time for scheduled maintenance and upgrades.
- **Scope of Consent.** Your consent to receive Communications and do business electronically, and our agreement to do so, applies to all of your interactions and transactions with BeVerified, Inc., whether or not you are a borrower creating a virtual storage file, or a lender with a valid subscription.
- **Hardware and Software Requirements.** To access and retain the Communications electronically, you will need to use a computer with the latest version of Internet Explorer or equivalent software, and hardware and or software capable of running this software and access to the internet.
- **Your Ability To Access Disclosures.** By completing and submitting your registration request, you agree that you can access the Electronic Disclosures in the designated formats described above.
- **Consent.** By completing and submitting your registration request, you consent to having all disclosures provided or made available to you in electronic form and to doing business with BeVerified electronically.
- **Withdrawing Your Consent.** You may withdraw your consent to receive Communications electronically by contacting us in the manner described below. If you withdraw your consent, from that time forward (1) you cannot place any further information on the BeVerified website, (2) any pending verifications or previous verifications will automatically be terminated, and be removed from the BeVerified website, and (3) if you are a registered lender or borrower, you will not be able to access the BeVerified website. The withdrawal of your consent will not affect the legal validity and enforceability of any Non-Disclosure Agreements or Powers of Attorney you have signed with BeVerified Inc, or any electronic Communications provided or business transacted between us prior to the time you withdraw your consent.
